

Application for Exterior Building Improvements Form

Submission of this application is required by Unit Owners planning to replace the original exterior doors, windows or light fixtures for their Units. A separate application is to be submitted for a satellite dish. The relationship between Unit Owner and their vendor(s) & contractor(s) is exclusive meaning the Association is not responsible for any deposits or other costs not refunded by a vendor(s) and/or contractor(s) in the event that this application is rejected.

IMPORTANT NOTICE: The Association recognizes that over time vendors/manufacturers may go out of business, change company names or locations, or rename or renumber products. In those scenarios or in any other situation that prevents use of exact replacement items, Unit Owners must seek out comparable products that are consistent with Association rules and receive prior written approval from the Association for any substitution. Approval of an "Application for Exterior Building Improvements" does not guarantee that the installation of the item(s) described in the request will be permanent. After installation the Association will inspect the end result to ensure that Unit Owners & the vendor have complied with appearance & installation requirements. If an installation does not meet requirements, the Unit Owner is responsible for all labor & material costs to bring the item(s) into compliance. Failure to comply may result in enforcement & ongoing assessments to the Unit Owner.
