MINUTES

TREASURER'S REPORT

WETHERINGTON REPORT

President Moses presented the following highlights:

- Brought Wetherington's current insurance policy with State Farm in compliance with SB61. The Fidelity bond was increased.
- The Rules Book was updated so all rules are in one place.
- The main water lines on Wetherington Lane and Barrington Way will be serviced by Wooster City because of the established utility easement. However, the association's water lines are private property and lack an easement. Therefore, we established a contingency fund in case of a water line break.
- The trees on the ravine, Wetherington Lane, and Barrington Way are hot-button issues.
- Wetherington projects include:
 - A reserve study is scheduled for the summer of 2023
 - Bench project completed
